We at SVLS would like to say thank you for all your support and working with us to be able to get our kids back physically in school this year. As much as many of these precautions may be somewhat of an inconvenience, we hope they can be seen by everyone involved as steps each of us can take to keep our children in school as often as possible.

Daily Student Health Assessments and Temp Checks

With new guidance from the CDC and at the recommendation of the Calumet County Health Department, we are no longer going to require students to have their temperature taken when they come to school in the morning, beginning after Labor Day. We will continue temperature checks through the end of this week. Instead, we are asking that all parents conduct a daily health assessment for their child(ren) each morning, according to the Daily Home Screening document that is attached. Consider using this week to familiarize yourself with the Daily Home Screening. SVLS will not be collecting assessment logs from families; we are trusting that you as parents will conduct the screenings; and if your child is sick, please do not send them to school. If your children are ill or are exhibiting symptoms, please contact the school office to let us know you're keeping them home and to share with us some information about their symptoms. Thank you!

As a requirement of being a Wisconsin Parental Choice Program school, we are to provide the parent or guardian of each student enrolled in or attending the school a copy of the educational options available to children. Morning-only EDP available after Labor Day

We are happy to inform you that we will be able to offer K-8 EDP (mornings only) up to 5 days per week, whenever school is in session, starting as early as 7:00 a.m. and going until 8:15 a.m. Our EDP leader will be Mrs. Patty Block, who also serves as our kindergarten classroom aide. The rate for EDP is \$4 per hour per child, billed in 15-minute increments. Your child will have brought home (or will be bringing home) login information specific to him/her and to you. Please take some time to set up online access to Jupiter Ed. If you did this in a previous year, your login information should have remained the same.

Daily Home Screening for Students

Parents: Please complete this short check each morning and report your child's information [INSERT YOUR SCHOOL REPORTING INSTRUCTIONS] in the morning before your child leaves for school.

SECTION 1: Symptoms

If your child has any of the following symptoms, that indicates a possible illness that may decrease the student's ability to learn and also put them at risk for spreading illness to others. Please check your child for these symptoms:

	Temperature 100.4 degrees Fahrenheit or higher when taken by mouth
	Sore throat
	New uncontrolled cough that causes difficulty breathing (for students with chronic allergic/asthmatic cough, a change in their cough from baseline)
	Diarrhea, vomiting, or abdominal pain
	New onset of severe headache, especially with a fever

SECTION 2: Close Contact/Potential Exposure

	Had close contact (within 6 feet of an infected person for at least 15 minutes) with a person with confirmed COVID-19
	Traveled to or lived in an area where the local, Tribal, territorial, or state health department is reporting large numbers of COVID-19 cases as described in the Community Mitigation Framework
	Live in areas of high community transmission (as described in the Community Mitigation Framework) while the school remains open
